## Judicial Clerkships—Class of 2011

### 2Ls:

It is time to start thinking about **applications to judicial clerkships**. There are many of these post-graduate opportunities at both the state and federal level including those with Bankruptcy, Magistrate, and Administrative Law Judges. **All of these clerkship opportunities can provide an intense tutorial on research, writing, legal analysis, and styles of advocacy. You will also gain an insider's perspective to the court system, expand your network, and enhance your resume.**

The application process for federal clerkships and many state clerkships begins now and ends in early September. Interviews are typically scheduled from September onwards, and are held until individual clerkship positions are filled. Some state clerkships follow a similar schedule while others consider applicants as early as the Spring Semester of their second year.

The Online System for Clerkship Application & Review (OSCAR) facilitates the application process and allows you to submit paperless applications for free to a majority of federal judges. In addition, UC Davis will pay for the postage of up to 150 paper applications if you email the names and contact information of your three recommenders by April 30th to [judicialclerkships@law.ucdavis.edu](mailto:judicialclerkships@law.ucdavis.edu), meet with Ali Shinsato, Assistant Director of Career Services and Judicial Clerkships, before the end of this semester, and adhere to certain other deadlines.
