Integrity and Ethics in the Offer and Acceptance Process

Although layoffs, deferrals, and rescissions have recently clouded the legal market landscape, in these challenging economic times, integrity and professionalism by job seekers is more important than ever. As law students, you begin to develop your professional reputation the moment you start law school. Conducting your job search with integrity is essential to your reputation. What does it mean to conduct your job search with integrity?

- Be Respectful of Employers.** Show up to interviews on time and well-prepared. If you have to cancel an interview, provide as much notice as possible. If an emergency arises and you miss an interview without notice, send an apology to the employer immediately, even if you are no longer seeking employment with them.
- Do NOT Renege.** Give careful consideration before accepting a job offer. **Once you have accepted a position, even an unpaid one, it demonstrates a lack of integrity to continue interviewing to see if something "better" comes along.** You expect the employer to honor their commitment, it is equally important that you honor yours.
