When corresponding with attorneys and other professionals, be it through formal job applications, requests for informational interviews, or email, be sure to address them appropriately. For women, *Ms.* is the default form of address, unless you know positively that a woman wishes to be addressed as *Mrs.* Like the male designation *Mr.*, the use of *Ms.* does not reflect marital status.
