DO I QUALIFY FOR “DIVERSITY” OPPORTUNITIES?

“Diversity” encompasses more than race and ethnicity. Many diversity programs also seek individuals based on disability, socio-economic disadvantage (e.g. first generation college and/or law school graduate), gender identification, and sexual orientation. Due to underrepresentation of women in the profession, many programs are open to *all* female applicants. Read the application criteria carefully before you disqualify yourself from something for which you may be eligible.
