The nationally recognized Capital Fellows Programs are an outstanding opportunity to engage in public service, prepare for a future career and gain experience under a seasoned mentor. 18 Assembly Fellows, 18 Senate Fellows, 18 Executive Fellows, and 10 Judicial Administration Fellows are selected annually to work 10-11 months as full-time staff-members in the California State Assembly, California State Senate, California Executive Branch or within the California Judiciary.
