**Transcripts**

Some employers request transcripts. Unless they specifically request an official transcript which is rare, a copy of your unofficial transcript is sufficient.

*Creating an Unofficial Law School Transcript*

Copy your transcript from SISWeb and paste it into a Word document; be sure to clean up the format. Add your name to the top of each page. An alternative is to create a table in Word, and below your resume header enter your transcript information. Either method you choose, save the Word document as a PDF before you submit it electronically.

*Ordering Official UC Davis Transcripts*

Official transcripts must be ordered through the main campus Registrar's Office. Information on how to order an official transcript is available at <http://registrar.ucdavis.edu/html/transcripts.html>. Please note that you cannot upload to Symplicity a scan of an official transcript as the file size is too large.

*Undergrad or Non-Law School Transcripts*

Some employers request an undergraduate or other non-law school transcript. Please use one of the methods described above to create an unofficial transcript. We recommend that you use the same format across all transcripts submitted.
