

- Follow up on pending applications with a brief email reaffirming interest and checking on status.

#### **REED SMITH'S 2012 DIVERSE SCHOLARS PROGRAM**

The Diverse Scholars Program provides two \$15,000 awards toward tuition for the second year of law school, as well as a paid summer associate position after completion of the second year of law school. The program is open to first-year law students who have demonstrated excellent academic scholarship and a commitment to diversity, inclusion and community.

Scholarship applicants must submit a resume, a completed application, two personal statements, law school transcript, undergraduate transcript and a legal writing sample as part of the application process.
