Save the Date! Speak to an Army JAG Event -- September 5th and September 12th

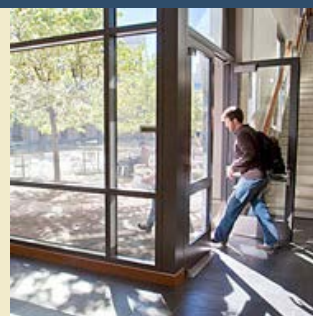
