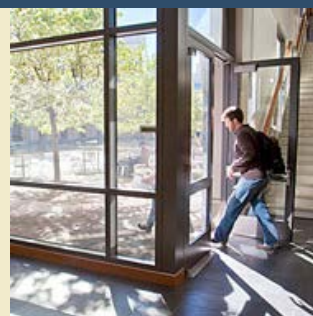

MANDATORY SURVEY AND SYMPPLICITY ACCESS- First year students will soon gain access to Symplicity, our web-based system that houses job, externship, and on-campus interview postings from law firms, government agencies and public interest organizations.
