Summer Ethics Fellowship for Law Students & Recent Graduates

FASPE (Fellowships at Auschwitz for the Study of Professional Ethics) is now accepting applications for its 2017 Law program.

FASPE Law is a fully-funded, two-week summer program that uses the conduct of lawyers and judges in Nazi Germany as a launching point for an intensive study in contemporary legal ethics. **FASPE Law** is predicated upon the power of place. Fellows visit Auschwitz and other sites in Germany and Poland where they consider how to apply the lessons of history to the ethical challenges they will face in their careers.

In 2017, the program will take place from Sunday, May 21 to Friday, June 2. (Fellows are expected to arrive in Europe by Saturday, May 20.) <u>All program costs are covered, including round-trip travel from New York to Europe, European travel, lodging, and food.</u> FASPE Law Fellows travel and share some seminars with Fellows in the FASPE Business and Journalism programs.

FASPE Law is open to current JD and LLM students and those who received a JD or LLM between May 2016 and January 2017. It is designed to address ethical challenges in all fields of law, including the private sector, public interest organizations, and the government.

MANDATORY SURVEY AND SYMPLICITY ACCESS

First year students now have access to Symplicity, our web-based system that houses job, externship, and on-campus interview postings from law firms, government agencies and public interest organizations. Symplicity also provides announcements of upcoming events and access to career development resources. Each first year student has their own individual Symplicity account with a username and password. Career Services emailed 1Ls in early October with your Symplicity account information. On your first login to the database you will need to provide some profile information and fill out a short career survey.

Open Society Institute Announces New Public Interest Fellowship

The Soros Equality Fellowship

"We are pleased to announce the launch of a new initiative at the <u>Open Society Foundations</u> (OSF): the <u>Soros Equality Fellowship</u>. The Fellowship award includes \$80,000 to \$100,000 over the course of a 12 to 18 month period, accompanied by the requisite skill building, mentorship, and support to ensure a fluid leadership pipeline between early career promise and later-career expertise. This approach recognizes the power of individuals to use a variety of tools, from traditional advocacy to <u>the arts</u>, to impact change and uplift the mission and values of an open society.

The Fellowship is also intended for a much broader universe than the traditional civil rights activist and contemplates support for individuals spanning a variety of fields. Its main goals are to support an individual's advocacy, artistic expression, cultural impact, community empowerment, narrative change, public opinion efforts, or technology innovation. For example, it might attract a free-lance journalist to produce a year-long investigative series, a documentary filmmaker to produce a short film examining the intersections of race and gender, or a coder to create anti-racial profiling software.

We're inviting applicants to be bold, innovative, unprecedented, and audacious in their submissions. In the advocacy realm, the aim is to support outstanding individuals-including lawyers, advocates, grassroots organizers, researchers, and others with unique perspectives-to undertake efforts to combat racism and xenophobia at the local, state, and national levels. Projects may range from impact litigation to public education to coalition-building to grassroots mobilization to policy-driven research. The aim of the Fellowship is to incubate innovation, promote risk-taking, and develop new ways of thinking that challenge our existing assumptions. The proposed project should add considerable value to the racial justice field and inspire new approaches to address issues of disparity and discrimination.

Everything You Need to Know About Government Honors Attorney Programs

For the Class of 2017:

Entry-level attorney positions in government (the federal government especially) can be tough to come by. One major exception: government honors programs. Each year, many government departments recruit and hire for a limited number of openings reserved for recent graduates. Competition for these programs is often intense, but grades are only one part of what the agencies usually look for. Commitment to working in government, subject-matter expertise and/or experience, and long-term potential are all important factors, so everyone interested is encouraged to apply.

Hiring for government honors positions varies by agency, but are frequently quite early. Some deadlines have passed already, but many others are yet to come.
