Chief Justice of California

Sworn into office in January 2011, Chief Justice of California Tani G. Cantil-Sakauye was the first Asian-Filipina American and the second woman to serve as the state's chief justice. Since then, she has emerged as one of the country's leading advocates for equal access to justice, civic education, and reform of court funding models and procedures that unfairly impact the poor. As leader of California's judicial branch and chair of the Judicial Council, Chief Justice Cantil-Sakauye has led the judicial branch out of the state's worst fiscal crisis since the Great Depression. She has improved the branch's efficiency, accountability, and transparency in how it conducts business, sets policy, and discloses information. Chief Justice Cantil-Sakauye is a graduate of UC Davis King Hall School of Law, Class of 1984.

Douglas Carstens

Douglas Carstens is the Managing Partner of a small environmental law firm, Chatten-Brown Carstens & Minteer LLP (CBCM), based in Hermosa Beach and San Diego. Wade Crowfoot

California's Natural Resources Secretary

Wade Crowfoot was appointed California's Natural Resources Secretary by Governor Gavin Newsom in January 2019.

Secretary Crowfoot oversees an agency of 19,000 employees who protect and manage California's natural resources. This includes the state's forests and natural lands, rivers and waterways, coast and ocean, fish and wildlife, and energy development. As a member of the Governor's cabinet, he advises the Governor on natural resources and environmental issues.

Secretary Crowfoot believes good natural resources management helps natural places thrive and allows communities and our economy to prosper. His key priorities include: Building California's resilience to climate change-driven threats, including wildfire, drought, flooding and sea-level rise.

Expanding access to parks, natural places and outdoor recreation for all Californians. Preserving California's world-renowned biodiversity of plants and animals.

Prior to leading the Natural Resources Agency, Crowfoot served as chief executive officer of the Water Foundation, a nonprofit philanthropy that builds shared water solutions across the American West. Before that Crowfoot served in Governor Jerry Brown's Administration as deputy cabinet secretary and senior advisor to the Governor. He also previously served as West Coast regional director for the Environmental Defense Fund and a senior environmental advisor to then-San Francisco Mayor Gavin Newsom.

Secretary Crowfoot received a bachelor's degree in political science from the University of Wisconsin-Madison in 1996 and earned a master's degree in public policy from the London School of Economics in 2004, graduating with honors.

A native of Michigan, Crowfoot grew up spending his summers outdoors at a YMCA camp and at his family's remote cabin in Northern Ontario. Upon moving to California in the mid-1990s, he became an avid hiker and backpacker and marks his first time in the redwoods at Big Basin State Park as one of his defining California moments. Now he spends his time outside of work hiking and camping with his wife, Lisa, and their young daughter.

Christopher Elmendorf

Martin Luther King, Jr. Professor of Law, UC Davis

Professor Elmendorf's varied teaching and research interests include election law, property and land-use law, statutory interpretation, and administrative law. He has published widely in top law journals, including the *Yale Law Journal, Columbia Law Review, University of Chicago Law Review, New York University Law Review, University of Pennsylvania Law Review, California Law Review, Duke Law Journal*, and *Cornell Law Review*, as well as leading peer-reviewed political science journals such as *American Journal of Political Science, Political Analysis, Political Research Quarterly,* and *Political Behavior.* His work has been funded by the National Science Foundation, the MIT Election Science & Data Lab, and an Interdisciplinary Research Grant from the UC Davis Committee on Research.

From 2006-2010, he served as Executive Director of the Center for Law, Energy & the Environment and as a Lecturer in Residence at the U.C. Berkeley School of Law. From 1977-2006, he served in various legal capacities with the California Department of Justice, culminating as Chief Deputy Attorney General for Legal Affairs (2003-06). During most of his career with the Department, Frank focused on constitutional, environmental, land use and public land management issues. Since leaving the California Department of Justice in 2006, Frank has served on a number of California state policymaking and advisory bodies. He served on the Board of Directors of the California High Speed Rail Authority from 2014-15. Frank has worked on CEQA issues for a half-century, beginning in 1972 when as a law student he participated in King Hall's moot court competition based on a problem modeled on the California Supreme Court's iconic Friends of Mammoth case in which the Court would issue its decision later that year. Mr. Frank received his law degree from the University of California at Davis in 1974.

William Fulton

Bill Fulton is the author of Guide to California Planning, the standard urban planning textbook for California, and editor and publisher of California Planning & Development

Report, the state's leading subscription publication on land use planning. He serves as director of the Kinder Institute for Urban Research at Rice University. During his career, Bill has served also served as Mayor and City Councilmember in Ventura, Director of Planning for the City of San Diego, a Principal and Shareholder at the planning consulting firm now known as Placeworks, and Vice President for Policy at the advocacy group Smart Growth America. He also taught in the UC Davis Extension Land Use and Natural Resources certificate program for more than 20 years. Bill holds an M.A. in urban planning from UCLA.

Kevin R. Johnson

Kevin R. Johnson is Dean, Mabie-Apallas Professor of Public Interest Law, and Professor of Chicana/o Studies. He joined the UC Davis law faculty in 1989 and was named Associate Dean for Academic Affairs in 1998. Johnson became Dean in 2008. He has taught a wide array of classes, including immigration law, civil procedure, complex litigation, Latinos and Latinas and the law, and Critical Race Theory. In 1993, he was the recipient of the law school's Distinguished Teaching Award.

A regular participant in national and international conferences, Dean Johnson has also held leadership positions in the Association of American Law Schools and is the recipient of an array of honors and awards. He is quoted regularly by the **New York Times**, **Los Angeles Times**, and other national and international news outlets.
