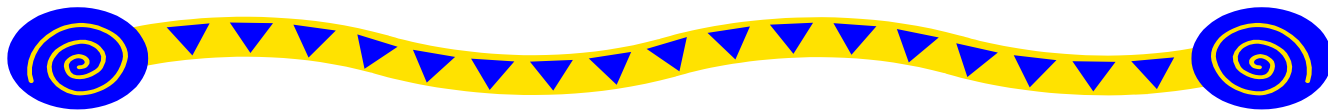

DIANE AMANN is visiting this fall at Boalt Hall. She published an article in the **Transnational Law and Contemporary Problems** and participated in (1) a conference co-sponsored by the governments of Finland, Germany, and Jordan, the International Center for Transitional Justice, and the Crisis Management Initiative, in Nuremberg, Germany; (2) a discussion on habeas corpus at the San Francisco Jurisprudence Café, sponsored by Morrison & Foerster's Jim Brosnahan; (3) an AALS and American Society of International Law conference; and (4) a conference at Cardozo law school; and (5) a conference of the U.S. District Court, Northern District of California. Diane was quoted in the in **Agence France Presse** and

the **L.A. Times**, and was interviewed by radio in San Francisco and French TV 24.

KEITH AOKI published symposium articles in the **UC Davis Law Review**, **University of Houston Law Review**, and **Michigan State Law Review**. The **Oregon Review of International Law** published his most recent article, "(In)visible Cities: Three Local Government Models, Immigration, Non-Citizen Voting and Language Regulation."

In May, **ANDREA BJORKLUND** served on a panel at an international law conference in Washington, D.C. In June, she presented a paper at Columbia Law School, and at the AALS/American Society of International Law joint conference. Andrea's latest article will appear in the **Hastings Law Journal**.

JENNIFER CHACÓN's article "Unsecured Borders," was published for the **Connecticut Law Review** and the subject of commentary by two senior scholars. She will publish articles this fall in the **University of Chicago Legal Forum** and the **Wisconsin Law Review**. In July, Jennifer presented a paper at the Law and Society annual conference in Berlin. She serves as convenor of the Immigration Policy Committee for Senator Barack Obama's presidential campaign.

HOLLY COOPER spoke at the World Jurist Association's annual conference. She and her students prevented the removal of a Moroccan client. Holly is teaching an immigration workshop at San Quentin Prison and organizing noncitizen defendants to convince state public defenders to properly advise criminal defendants of the immigration consequences of criminal convictions. She is working with the **American Civil Liberties Union** to determine the legality of transfers of California noncitizen prisoners to Mississippi. Holly was reappointed as a special liaison to the Office of Chief

Immigration Judge and the Board of Immigration Appeals.

HOLLY DOREMUS and Dan Tarlock (Chicago-Kent) completed the manuscript entitled **Anatomy of a Water War in the Klamath Basin: Macho Law, Combat Biology and Dirty Politics**. The book is scheduled for publication in April 2008.

CHRIS ELMENDORF was invited to join the Tobin Project's "Institutions of Democracy" working group, established in honor of the late Nobel Laureate James Tobin.

BOB HILLMAN published updates to the **Lawyer Mobility Treatise** and **Securities Regulation** casebook.
