DIANE AMANN recently made presentations at Columbia, Princeton, Occidental, and the U.S. Military Academy (West Point). She made a presentation at the inaugural meeting of the French-American Network on the Internationalization of Law at the Collège de France, Paris. Diane published "John Paul Stevens, Human Rights Judge," in the **Fordham Law Review**, and "Transnationalism Confronts Transition," in **Revue de Science Criminelle et de droit penal Compare**. She was elected to the Executive Committee of the American Society of International Law and named to the planning committee for the 2007 AALS Midyear Meeting on International Law. Diane recently was quoted in the **Sacramento Bee**, **Contra Costa Times**, and **The Examiner** (Washington, D.C.).

This spring, Jennifer made presentations at UC Berkeley's Institute for the Study of Social Change, Western Law Professors of Color Conference, Immigration Law teachers workshop at UNLV, and at the UC Davis "War on Terror" teach-in. Jennifer recently was quoted on several occasions in the **Sacramento Bee**, and was interviewed on local television.

His latest work will appear in the **California Law Review** and the **Cleveland State Law Review** (symposium on the Margaret Jane Radin's scholarship). HOLLY DOREMUS published a chapter in volume 2 of **The Endangered Species Act at 30**, and a brief treatment of the ESA and associated controversies for the Center for Progressive Reform website. Her paper on conservation planning has been accepted for publication by the peer-reviewed journal **BioScience**. Holly spoke at conferences at Boalt Hall and Indiana (Bloomington), and gave workshops at UC Berkeley and the Bren School at UC Santa Barbara. CHRIS ELMENDORF's article titled "Advisory Counterparts to Constitutional Courts," was selected in

the 2006 Stanford-Yale Junior Faculty Forum competition, and was accepted for publication by the **Duke Law Journal**. In June, he will present the paper at Yale Law School.

Ed lectured for the California Appellate Defense Counsel and American Bar Association Criminal Justice Section, and at the Interamerican University in Puerto Rico.

The **California Law Review** will publish **ELIZABETH JOH**'s article "Discretionless Policing: The Fourth Amendment and Technology." Her article in the **Northwestern University Law Review** was highlighted in an **ABA Journal E-Report** story (Jan. 27).

Chief Judge Mary Schroeder appointed **MARGARET JOHNS** to serve as Chair of the Ninth Circuit's Advisory Rules Committee.

KEVIN JOHNSON completed "The Story of Whren v. United States: The Song Remains the Same," for **Race and Law Stories** and published op-eds in the **Houston Chronicle** and **Diverse Online**. He gave presentations at UC Berkeley, Arizona, California Western, UC Davis, University of Nevada Las Vegas, and American. Kevin was recently quoted in the **USA Today**, **L.A. Times**, **National Jurist**, and other newspapers and appeared on several local news shows. This spring, he was reelected president of the board of directors of Legal Services of Northern California and elected to the board of directors of the Mexican American Legal Defense & Education Fund.

Among many other high-profile assignments, John served on the Task Force on UC Compensation, Accountability, and Transparency, which recently issued a report calling for fundamental reform of UC's procedures for determining and reporting executive compensation.
