DIANE AMANN published “Abu Ghraib,” in the **University of Pennsylvania Law Review**. The article received the American National Section of the International Association of Penal Law’s “Article of the Year” award. Diane recently made presentations (1) to the Office of the Legal Adviser of the U.S. Department of State; (2) as part of a RAND Corporation conference on law and terrorism; and (3) at the UCLA Center for Social Theory and Comparative History. She was named “Collaborateur et correspondant étranger” (Collaborator and Foreign Correspondent) of the **Revue de science criminelle et de droit pénal comparé** (Review of Criminology and Comparative Criminal Law). In August, Diane was quoted in a news article on racial profiling on [www.FoxNews.com](http://www.FoxNews.com).

In May, Visiting Professor **DEBBIE BASSETT** attended the annual meeting of the American Law Institute (ALI); she serves on the Members Consultative Group for the Principles of the ALI’s Law of Aggregate Litigation project. Debbie published “Recusal



and the Supreme Court” in the **Hastings Law Journal** and “Redefining the ‘Public’ Profession” in the **Rutgers Law Journal**. Debbie also published new editions of **Problems in Legal Ethics** and **California Legal Ethics**, and the 2005 supplement to **Cases and Materials on Civil Procedure**.

**KEVIN JOHNSON** published (1) a chapter for a book entitled **Immigration Stories** on important Supreme Court immigration decisions; (2) a chapter on racial profiling in **Neither Enemies Nor Friends: Latinos, Blacks, Afro-Latinos**; and (3) articles in the **UCLA Chicano-Latino Law Review** (symposium), **African-American Law & Policy Report** (with Angela Onwuachi-Willig), and **U.C. In August, she delivered a paper at a USC faculty workshop. This summer, Madhavi was interviewed for a radio show on women's rights in the Middle East. She was quoted in **Women's e News** and in the **Washington Times**. Madhavi chaired a city of Davis committee appointed by

the Board of Education to proposed names for a new Davis elementary school.

Davis colleagues, Marty released a report entitled “Unprecedented Urgency: Gender Discrimination in Faculty Hiring at the University of California.” The **New York Times**, **San Francisco Chronicle**, **Higher Education** newsletters, and newspapers throughout California reported on the study. The Capital Public Radio show “Insight” devoted an hour to discussion of the report. Marty participated in a conference presented by Swissnex, the economic arm of the Swiss Consulate in San Francisco, comparing the status of women faculty in the U.S. with women faculty in Switzerland. She commented in the **Sacramento Bee** and the **San Francisco Daily Journal** on a recent California Supreme Court decision. Marty briefed reporters from the **Sacramento Bee** on employment relations and collective bargaining in the public sector.

This summer, **TOBIAS BARRINGTON WOLFF**, away at Northwestern this fall, published a conflicts of law article in the **University of Pennsylvania Law Review**. He also published two op/eds in the **Los Angeles Times**, one on the U.S. military’s “Don’t Ask, Don’t Tell Policy,” and another on Governor Schwarzenegger’s threatened veto of a bill authorizing same sex marriages. Tobias was asked to serve on a blue ribbon advisory committee panel to review the proposed redrafting of the Federal Rules of Civil Procedure.
