## FROM THE ASSOCIATE DEAN



## ABOUT THE UNIVERSITY OF CALIFORNIA

The UC Davis University Library contains more than three million volumes, and the Mabie Law Library houses more than 375,000 print volumes and volume equivalents, and provides access to a wealth of licensed online resources as well as electronic access to journals and databases via the California Digital Library.

The UC Davis School of Law is a top-tier U.S. law school. Our students consistently perform well on the California bar examination. All courses offered through the International Law Programs are MCLE-approved by the California and New York Bar Associations. The International Law Section of the State Bar of California is a co-sponsor of these programs.



## ABOUT THE CITY OF DAVIS

The UC Davis campus is located in the city of Davis. Davis has a population of 68,111 and is a popular place for professionals and their families because it is safe, comfortable and has a variety of recreational opportunities. Known as an ecologically aware and socially innovative town, Davis has more than 160 kilometers of bicycle paths and boasts the highest percentage of bicycle commuters in the United States. And, my final research and paper for the LL.M. was published in a law review!

## UC DAVIS SCHOOL OF LAW: A FAMILY TRADITION

Javier Angel Luzzi first joined the UC Davis International Law Programs in 1995. Luzzi works in Argentina as the Country Legal Director of Cencosud S.A. (the third largest retail company in Latin America) while also lecturing at the Universidad de Buenos Aires. "That first program opened my mind," Luzzi says, "especially with things that were very helpful in my professional practice later."

The learning experience was so valuable that, twenty-two years later, Luzzi returned to UC Davis for summer law programs—joined by his daughter, Marina Luzzi Santana (an undergraduate student in International Relations exploring a law career), and his wife, Valeria Masuyama (a professional working in a family business), who both participated in courses as well.

# ADVANCED LAW DEGREE

## MASTER OF LAWS (LL.M.)

A one- or two-year, in-residence program  
August – May each year;  
August or January starts available

The UC Davis School of Law LL.M. offers a superior educational experience for foreign lawyers, judges, prosecutors and other legal professionals. Classes are taught by outstanding faculty scholars, and students are integrated into J.D. classes. The program is designed around individual student needs, and LL.M. students can pursue a general course of study or a specialization from an area within the UC Davis School of Law curriculum such as Business Law, private and public International Law, Criminal Law and Procedure, Intellectual Property, Human Rights and Social Justice Law, Public Interest Law, Environmental and Natural Resources Law, Health Law and Bioethics and many others. Students may also take a pre-Bar study program. UC Davis offers one- and two-year options.

LL.M. candidates must complete a minimum of 20 semester units. Foreign LL.M. candidates take two courses especially designed for foreign law graduates that provide a foundation for understanding the U.S. legal system. Participants earn the remainder of their required course credit by taking regular courses at the UC Davis School of Law with American J.D. students.

The law school also admits foreign LL.M. candidates on a thesis rather than a course basis. The thesis track requires a substantial proposed research project falling within the area of expertise of a law faculty member who is willing to supervise the student's research and who strongly recommends graduate study for the applicant. The law school accepts thesis-track students only if their proposed thesis is likely to make a significant scholarly contribution.

LL.M. candidates must complete their degree during two consecutive semesters of residential study for the one-year program; please inquire about our two-year LL.M. option. LL.M. candidates are encouraged to enroll in **Orientation in U.S.A. Law**, offered the month before the Master of Laws (LL.M.) program begins.

To ensure a top quality experience for its students, the Master of Laws (LL.M.) program is selective. Applicants must have a minimum TOEFL iBT score of 88 (or 230 computer-based or 570 paper-based score). An IELTS score of 6.5 is also acceptable.

Graduates of this master's degree program have gone on to sit for the bar examinations in New York and California in order to become U.S. attorneys.

## ORIENTATION IN U.S.A. LAW

Sunday, July 7 – Saturday, August 3, 2019

### PROGRAM AUDIENCE AND CONTENT

This summer we celebrate the 30th anniversary of this superior international summer law program. Lawyers, judges, prosecutors and defenders, notaries, law professors, pre-LL.M. candidates and business professionals attend this program to gain a better understanding of the theories and practices of the U.S. legal system. Participants engage in more than seven units of classes, seminars and on-site observations. At the same time, participants enrich the program with diverse perspectives from their legal systems. While the program is fast-paced, there are numerous social activities that foster the building of strong and lasting friendships and professional connections.

Academic credit from this program may be applied toward the Licentiate in International Transactions Involving the United States.

This course is open to anyone from the legal or business community. There are no admission requirements or prerequisites. This program does not require a TOEFL score. However, we do recommend that participants have a good working knowledge of the English language as all lectures are in English.

## THE GLOBAL TRADING SYSTEM

Sunday, August 4 – Saturday, August 17, 2019

This program is designed for knowledgeable practitioners who wish to gain a working familiarity with the global trading system—including international trade, commerce and investments as well as international dispute resolution. The program consists of more than 50 hours of lectures, seminars and practicum. As part of the program, students engage in legal planning, problem solving, decision making and negotiations.

The course is open to anyone from the legal or business community. There are no other admissions qualifications or prerequisites required. This program does not require a TOEFL score. However, we do recommend you have a good working knowledge of the English language as all lectures are conducted in English.

## LICENSING ACADEMY IN INTELLECTUAL PROPERTY AND TECHNOLOGY TRANSFER

Sunday, June 16 – Saturday, June 29, 2019 (tentative)

This two-week program has been developed for international lawyers, technology managers and scientific professionals in the public sector or small-to-medium enterprises who want to understand successful U.S. models of intellectual property management. Participants will learn strategies and tactics for managing intellectual property (IP) that maximize the commercial success and public benefit of their research and development investments.

The course will cover topics\* such as U.S. and international IP protection, IP management for commercialization, licensing, IP issues in negotiating an international agreement, starting IP and technology transfer offices, start-ups and spin-offs from public-sector institutions.

This unique course is hosted by the UC Davis International Law Programs and Public Intellectual Property Resource for Agriculture (PIPRA). Lecturers include world renowned instructors from the UC Davis School of Law and other UC Davis campus departments, outstanding legal practitioners and business experts representing major U.S. firms.

Academic credit from the *Licensing Academy* seminar may be applied toward the summer International Commercial Law LL.M. This seminar also qualifies for continuing legal education (CLE) credit in New York and California. ### LICENTIATE IN INTERNATIONAL TRANSACTIONS INVOLVING THE UNITED STATES

Complete in two summers

Courses run Sunday, July 7 – Saturday, August 17, 2019

This innovative eight-week course of study can be completed in two summers, allowing foreign and domestic lawyers to leave their practices for short periods of intense study. With special emphasis on business and trade law, participants complete the *Orientation in U.S.A. Law program, four weeks of specialized programs (see reverse for selections) and a capstone writing project on an applied aspect of international law*. Examining the U.S. legal system in-depth provides participants with a model for comparative legal analysis and an understanding of a legal system that is considered highly responsive to the global marketplace. With this foundation, participants go on to study global trading systems and the dynamic financial and economic forces driving internationalization and trade liberalization.
