Guidelines for the Law School Writing Requirement:

The paper is an individually authored work of rigorous intellectual effort of at least 20 typewritten, doublespaced pages, excluding footnotes... (Reg 1.4C). The professor must review and comment on at least one draft, and the student must re-write the paper in accordance with the professor's comments. The professor may establish additional requirements, such as submission of outlines, bibliographies and/or exchange of multiple drafts.

Guidelines for Professional Skills Requirement:

Students are required to complete one or more course(s), totaling at least six units, designated as satisfying instruction in professional skills. Skills courses are noted with the following symbol on the course schedule: §

Guidelines for Classroom-based Law Courses:

Students must have a minimum of 68 classroom-based law units of the total 88 units to graduate. These units include all courses that regularly occur within a classroom, including Law 410A/B – Appellate Advocacy, clinics, and practicums. The one-unit professional development externship seminar (Law 424) is a classroom-based course and counts toward the 68 units. Courses completed as part of a King Hall study abroad program are also classroom-based.

Independent study units (Law 419 or 499), co-curricular units (law review, law journals, moot court and mock trial competitions, and LRW Tutor units), externship placement units, and non-law units taken in other UC Davis departments do <u>not</u> count toward the 68 units.

Students graduating with exactly 88 units may have a maximum of 20 non-classroom based/non-law units. Students graduating with more than 88 units may have more than 20 non-classroom based/non-law units, so long as you have a minimum of 68 law classroom-based units.

Semesters in Residence:

Students are required to complete at least six semesters as a full-time student at an ABA approved Law School. At King Hall, "in residence" means that you have earned at least 10 units during the semester.

Transfer Units: (limit of 30-31 units)

- Units taken at other ABA approved law schools or in other UC Davis departments count as transfer units.
- Some transfer units from other ABA approved law schools may count as non-classroom-based units if the units taken at the host school include non-classroom coursework.
- Transfer units from other UC Davis departments count as non-law units.

Credit Limitations

Of the 88 semester credits required for graduation, no more than 14 units may be earned in externship placement units.
