

**DEFERRED ACTION FOR CHILDHOOD ARRIVALS (DACA)

To qualify for DACA, you will need to demonstrate that you meet ALL of the guidelines described by U.S. Citizenship and Immigration Services (USCIS).

- Deeds, mortgages, rental agreement contracts
- Tax receipts, insurance policies
- Official records from a religious entity confirming participation in a religious ceremony
- Passport entries
- Birth certificates of children born in the U.S.
